### Federal Interior Minister attends comprehensive briefing at FIA Headquarters

Interior Minister directed Secretary Interior to review the notification to include and authorize FIA to obtain requisite data from cell Phone

companies. The Minister directed that Secretary Interior may hold a meeting with Secretary IT Ministry and Senator Mushahid Hussain to expedite enactment of law on Cyber Crimes. He directed FIA to negotiate in light of PTA terms & conditions with E-Mail Providers i.e. Google, Face book, hotmail etc to promptly obtain information

The Minister further directed FIA to forward a summary to MOI for purchase of cell phone locaters to enhance effectiveness of related wings and units of the agency. He expressed his dissatisfaction about actions taken against human traffickers and directed that Most Wanted Human Traffickers be arrested and compliance report be forwarded soon. He agreed with the proposal that on request of FIA immigration department the Interior Min-

istry will notify suitable re-

#### Rs 2794.4558 Million theft unearthed by **Electricity Gas & Oil Antitheft Unit** during the operations

Unit of FIA has registered 685 cases, and 665 accused arrested during country wide operations. Economic value of theft is more than 2794.4558 Million. Among total number of cases about 267 are from Punjab, 99 from Sindh, 202 from KPK, and 25 in Balochistan 118 from Islamabad. 690 persons arrested from all over the country. Economic value involved in these cases 2389.32 Million from Punjab which is very high as compare to other provinces. Where as from Sindh it was Rs 97 million, 216.7 million form KPK, and from Balochistan it was 1.7 million.

#### Revision of PC-I of IBMS

## Internal Accountability Unit takes action against corrupt Employees

FIA registered eight criminal cases against its own officers. FIA arrested its own officials and removed an assistant director for their alleged involvement in human trafficking The DG FIA after holding an inquiry held responsible Abbas Baloch Assistant Director; Afzal Niazi, Inspector; Aman Ullah, ASI and Sajid Munir, constable for alleged involvement in this case. Complete Challan have been submitted to the court. The accused officials has submitted a writ petition against the case. However High Court has not given instant relief to the petitioners at this stage of the case.

It will carry out monitoring of immigration staff regarding deportees, inadmissible passengers and DFDs.

In addition measures will be taken to improve the public image of FIA immigration wing at national as well as international level by ensuring passenger friendly environment.

FIA in its bid to revamp the department has repatriated 34 officer to their parent departments in pursuance of Islamabad High Court Orders. FIA has decided to repatriate officers belonging to other departments on deputations and having substitute with-in organization.

FIA Academy imparts training on recruitment and conduct in-service courses for capacity building of cers in the field of Human Trafficking, FIA Academy regularly conducts Cyber Crime, Money Laundering, Anti Corruption, Spurious Drugs etc, including courses in collaboration with foreign embassies and international organizations.

### Integrated Border Management System

2002 FIA launched computerized immigration system for the international Travelers, by the name of PISCES with support of US government. On expiry of PISCES, an indigenous developed border management system "IBMS" launched on 15th Feb 2011 with local funding. IBMS has been successfully deployed at 14 major sites. 12 remaining sites will be deployed with IBMS till 30<sup>th</sup> June 2014. IBMS Maintains ECL and provide travel records to police, ANF and ministries/ departments. It tracks overstay cases and documents authentication.



Training Academy conducted several courses and specialized trainings in a professional way. FIA Academy organized 16 trainings in which 228 FIA's officers/officials participated. Moreover officers of ANF, PAF, NAB, Air Headquarters, Corps of Military Police School DI Khan and ASPs from National Police Academy visited FIA academy during year 2013.



## National Response Center for Cyber Crime ( N R 3 C )

deal with "Cyber Crimes" such as Hacking, Internet Frauds, Social Networking Crimes, Online Harassment / blackmailing, Grey Traffic, Credit card skimming, illegal data transmission, frequency jamming, transmission interception NR3C unit was established with in FIA. In 2007 NR3C started as a PSDP funded project to be very first effort of its kind by the Government of Pakistan that could tackle and investigate crimes involving ICT. NR3C project has reduced the gap between the capabilities of criminals to commit crimes using latest technologies and FIA as a federal law enforcement. agency to investigate and prosecute such criminals.



## Tech

nical Wing was set up in early 1975, since than the wing is providing scientific assistance to various units of FIA, NAB, Islamabad Police, Azad Kashmir Police, Railway Police, Federal Ministries & Departments, Banks, Financial Institutions and provincial police departments. Three functioning sections of the wing are questioned documents section, finger print section and chemical analysis section.



#### Revamping of FIA

The Federal Investigation Agency which aims to be the premier professional organization as a federal investigative arm of the Government of Pakistan, has undertaken an organizational revamping process under the leadership of its Director General.

The overall objective of the revamping process is to deliver professionally with high integrity to secure maximum convictions, to refocus on money laundering and assets recovery, to intelligence-led monitoring of corruption and malpractices within the organization, and above all enhancing capacity of the Agency by utilizing and mobilizing the available resources.



Director General acknowledged the honesty and competence of Additional Director General Azam Khan at his farewell.



## IMPORTANT ACHIEVEMENTS OF FIA IN 2013

- \* Manifold increase in raids against grey traffic, 53 raids were conducted during 2013 whereas only 52 raids were conducted during 2009-12 by **NR3C.** Loss averted to national exchequer was 1500 Million during 2013 as compared to 763 Million during 2009-12.
- \* Federal Government reposed its trust in FIA by assigning special tasks such as operations against Electricity, Gas and Oil theft. Despite, shortage of resources, FIA EGOA Section showed marvelous performance from July to December, 2013. During this short period EGOA conducted hundred of raids all over the country, registered 711 Cases, arrested 692 accused and recovered 5564 Million.
- \* FIA revived its sophisticated CMS System. Now all cases of all zones and circles can be monitored on web.
- \* New APT Rules framed and submitted to MOI for approval.
- \* Minister for Interior approves FIA Liaison Office in Istanbul to help in curbing of illegal human trafficking.
- \* FIA Training Academy organizes several trainings and workshop for FIA and other organizations with collaboration of Australian and British High Commissions.

#### **AUSTRALIAN COOPERATION**

Australian have pledged to provide sophisticated equipment to enhance the capability in detection of criminals. In this connection they have already organized training workshops on Asset Tracing and Investigation, Advanced Document Examination Equipment Workshop. Australian high commission has also gifted document examination equipment to FIA Academy

#### **FIA-UK Collaboration**

has come up in a big way to assist in establishing the Immigration Vigilance Unit. Requisite training and equipment will also be provided by them. A software namely i2 has already been provided to FIA immigration wing while ICMPD is organizing Training programs for FIA officials on illegal migration with collaboration of British high commission.



## Toll free help line in SAARC members states

AARC is establishing Women and Child Victims' Centre in Pakistan to

protect rights of women and children in south Asian countries, FIA contributes as an executing agency in Pakistan.

## Establishment of Internal Accountability and Assets Tracing & Money Laundering Units

Federal Investigation Agency has established two more units namely Internal Accountability Unit and Assets Tracing & Money Laundering Units. The IAU unit is based at FIA HQ and they will primarily carry out intra-organization accountability and take cognizance of the FIA employees involved in misconduct, corruption, illegal enrichment and abuse of powers while asset tracing and money laundering unit will essentially focus in tracing the assets of the accused involved in mega corruption cases in country and abroad. This unit will also take up STRs received from FMU to trace out attempts of any money laundering in the country.

sponsoring a project for FIA. The Japanese Government will construct a Bomb Proof Data Centre and Forensic Investigation Labs. JICA has included it in its priority projects after the clearance of the concept paper by P&D.



FIA finds proofs of money transfer to foreign accounts, In a major breakthrough, the Federal Investigation Agency traced misappropriation of Rs. 1.8 billion in freight subsidies in Export Development Fund (EDF) during 2009-12, and TDAP officers embezzled huge amounts through fake firms, auditors, bankers etc. and fake claims on basis of fake documents. 15 arrested in TDAP-I case. Where as in TDAP-II case, Embezzlement /corruption of Rs 1.27 b into the incentives schemes entailing grants of different subsidies to the exporters have been found.

## Major Recoveries by FIA in EOBI Cases

amount of Rs 941 million has been recovered due to efforts of FIA. The owners of the properties have submitted cheques / pay orders of Rs. 2964 million to Honorable Supreme Court of Pakistan and some of them have given undertakings regarding payment of the rest of the amounts to the court, if EOBI decides to return their property.
