TERMS & CONDITIONS

1. The Contractor shall deposit an amount of Rs. 50,000/- (Refundable) as security to the cashier and outstanding amount / dues (if any) on expiry / cancellation of contract shall be recovered from the security.
2. The contractor shall be allowed to use utilities of FIA HQ by depositing Rs. 6,000/- per month to Cashier FIA HQ.
3. During the contract period standards of all food items regarding hygienic as well quality shall be maintained and will be checked periodically.
4. The contractor shall use the all crockery / furniture items at its own expense.
5. The contractor will provide food items to FIA employees at subsidized rates.
6. The validity of rates / tender should be for the period of one year after the acceptance of lowest bidder, and is extendable for one next year as the basis of performance of the contractor
7. Incomplete and late submitted tender will not be entertained.
8. Sealed Tenders with detail specifications must reach at logistic branch FIA HQ Islamabad on or before 07.10.2020 till 11:00 AM. Bids will be opened the same day at 11:30 AM.
