

3. The interested bidder shall submit pay order/bank draft of Rs. 25000/- against each vehicle in favour of DG/FIA. However, motorcycle will be auctioned as one lot.
4. The successful bidder shall have to deposit 25% amount of the offered price/bid on the spot.
5. All taxes advance tax shall be charged as per prevailing laws of Government of Pakistan.
6. Tender documents can be obtained from the addresses given above on the payment of Rs. 200/- per vehicle (non-refundable).
7. The interested parties are advised in their own interest to make themselves assured regarding clearance of documents and registration before auction with concerned ETO, otherwise this organization will not be responsible later on.
8. NOC for transfer of Vehicles will be issued to successful bidder and it is the responsibility of individual to get registration at their own.
9. In case of unforeseen circumstances or holidays announced by the government on the day of auction it will be treated postponed and will be open next working day or as decided and announced.
