

## **PREFACE**

**The first “Red Book” of wanted persons, absconders and proclaimed offenders involved in illegal immigration, human trafficking and human smuggling was issued in September 2006 containing the profiles of 69 such persons, Of whom, 18 had been arrested.**

**The second “Red Book” was revised and issued in December 2007 containing the profiles of 69 Most Wanted Traffickers (MWTs) which too included 17 against whom Red Notices had been issued by the Interpol. Out of these 24 have been arrested.**

**Now the third “Red Book-2009” has been revised and updated which comprises the profiles of 76 Most Wanted Traffickers involved in human trafficking/smuggling.**

**I must appreciate the efforts of Director Immigration and staff of the Anti Human Smuggling Branch FIA HQ who consolidated the data of all the FIA’s Anti Human Trafficking Circles. I also acknowledge cooperation extended by other Law Enforcement Agencies in curbing the menace of human trafficking. We are committed to improve our ranking in TIP listing issued annually by US State Department and next year we shall regain our old status of Tier-2. However, in the days ahead, focus on internal trafficking is called for.**

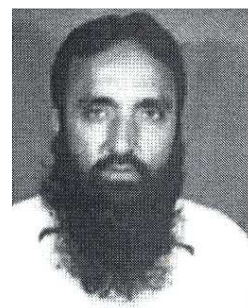

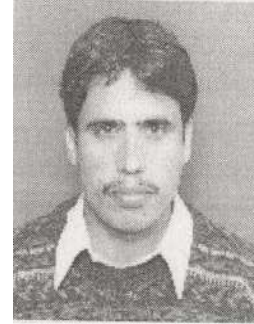

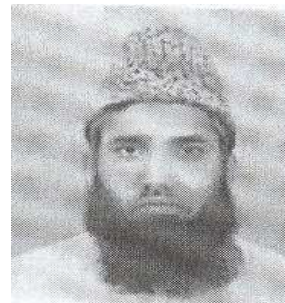
