Subject: REVISION OF VISA REGIME

In continuation to this Ministry's letter of even number dated 19th March, 2019 on the subject cited above, the following provision is inserted in Pakistan Visa Policy under the heading Visa on Arrival and after the words "Visa on Arrival will be augmented with Electronic Travel Authorization (ETA) subject to 48-72 hours prior application/intimation":-

"All Qatari Passport holders including Diplomatic Passports Special Passports and Ordinary Passports will be granted Visa on Arrival (Tourist/Visit) free of charge, with single or multiple entries, without requirement of ETA at any port of entry for a period of 30 days extendable by another 30 days subject to the following conditions:-

- i. Passport validity for at least 6 months;
- ii. Confirmed return ticket; and
- iii. Having cash equivalent to US \$ 1500/- or a valid credit card".
