#### CHARGE SHEET

WHEREAS, You, Mr. Syed Atif Hassan s/o Hassan Abbas, Head Constable (BPS-07), (under suspension) FIA Lahore Zone, while posted at FIA Immigration AIIAP Lahore, have committed act of omission and commission, which tantamount inefficiency and misconduct as defined in Rule 3 of the Civil Servants (E&D) Rules, 2020, as spelled out in the attached statement of allegations.

- WHEREAS, this act tantamount inefficiency and misconduct as defined in Rule 3 of the Civil Servants (E&D) Rules, 2020, on your part, therefore, you are liable for disciplinary action, which may entail imposition of major penalty including "Dismissal from service" among others, as prescribed in Rule-4 of said Rules.
- O3. AND WHEREAS, I, being Competent Authority in your case, have decided to proceed against you under the provisions of Civil Servant (Efficiency & Discipline) Rules, 2020, and consider that in the light of facts of the case and in the interest of justice, it is necessary to hold an enquiry through an Inquiry Officer.
- AND WHEREAS, I, undersigned in the capacity of Competent Authority, direct you to submit your written defense within 14 days from the date of receipt of this charge sheet directly to inquiry Officer, Ms. Saba Sattar (PSP), Deputy Director/Admn, FIA Lahore Zone, to conduct inquiry in your case, failing which, it shall be presumed that either you have no defense to offer or you have declined to offer the same and accept the charges and in that case action shall be taken ex-parte. #### STATEMENT OF ALLEGATIONS / GROUNDS OF ACTION

WHEREAS, You, Mr. Syed Atif Hassan s/o Hassan Abbas, Head Constable (BPS-07), (under suspension) FIA Lahore Zone, while posted at FIA Immigration AIIAP Lahore, have committed the following act of omission and commission, which tantamount inefficiency and misconduct ad defined in Rule 3 of the Civil Servants (E&D) Rules, 2020: -

- "I. You were granted 30 days Ex-Pakistan leave w.e.f 06-10-2022 to 04-11-2022 to proceed UK. You had to report for duty on 05-11-2022 but you did not join office.
- II. You were placed under suspension vide FIA Lahore Zone Office Order No. 31/2023 dated 24-01-2023 and Show Cause Notice dated 24-01-2023 was issued to you on the ground of absence from duty w.e.f 05-11-2022 to 05-01-2023 on the report of the Deputy Director FIA Immigration AIIAP, Lahore.
- III. The show cause notice was sent to the Deputy Director FIA Immigration AIIAP, Lahore for serving the same to you. Reportedly, the show cause notice was not served as you are abroad i.e. UK.
- IV. You did not report for duty till date after expiry of Ex-Pakistan leave and absent from duty w.e.f 05-11-2022 till to date and you did not submit reply of show cause notice."
- WHEREAS, this act tantamount inefficiency and misconduct as defined in Rule 3 of the Civil Servant (E&D) Rules, 2020, on your part, therefore, you are liable for disciplinary action, which may entail imposition of major penalty including "dismissal from service" among others, as prescribed in Rule-4 of the Rules, ibid.
