7. Evaluation of Technical Proposal

Based on the record/documentary evidence submitted by the bidders, each bidder shall be evaluated as per the Technical Evaluation Criteria at <u>Annex-A</u>. Minimum threshold for qualifying for financial evaluation shall be 70%.

Bidder shall quote the courier charges as per the format at **Annex-B** of this document.

9. Award of Contract



6. INDEMNITY:

11. FORCE MAJEURE:

Force Majeure events or conditions beyond the control of Courier Company and IBMS (FIA), such as acts of God, acts of terrorism, or similar acts, civil disturbances, or any other emergency beyond the parties control, which makes it inadvisable, illegal, or impossible for either party to this agreement to perform their obligations under this agreement as they relate to the performance. In case of such event, the agreement shall stand terminated and the courier company shall thereafter have no obligation to IBMS (FIA) and IBMS (FIA) shall not be required to pay to the courier company.

12. TERMINATION OF AGREEMENT:

If the courier Company breaches any terms and conditions laid down in this agreement and if such breach is not cured within thirty (30) days after receiving written notice from IBMS (FIA) specifying such breach in reasonable detail, IBMS (FIA) shall have the right to terminate this agreement by giving written notice thereof to the company, which termination shall go into effect immediately on receipt.
